


IGTC was featured in many successful meetings by Gary C. Martin, IGTC President, in Beijing last week. Much of his time was focused on promoting IGTC engagement to facilitate global trade of grains, oilseeds and other agri-bulks for food, feed, and processing in the context of China's value chain.

Meetings with IGTC Corporate Stakeholder COFCO and Member CNAGS regarding participation and support from both were much appreciated. Very informative meetings with the leadership of potential IGTC partner organization www.idmni.org provided for new information in China's approach to multinational institutions. Closing out the week Gary hosted a 'China Grain and Oilseed Reception' on Friday with grain trade and government colleagues from China and other countries around the world. Overall, the mission represented a significant step in forwarding the IGTC's global outreach via improved balance in geographical participation and increased leadership on key files.

Argentina has now joined the 10 other countries that plan to participate in the IPPC-WTO ePhyto Hub pilot in 2017, it has been confirmed. The addition of Argentina follows the development of ePhytos in the country at local level, and a visit by the IPPC to the city of La Plata in October 2016 (full story here).



Technical specifications for the Hub have now been finalised and it is expected that countries with existing national systems which have committed to participating in the pilot will be able to begin exchanges of electronic phytosanitary certificates by the third quarter of 2017. The IPPC is expected commission a report into the business plan of the Hub, focusing on costs and benefits; and a sustainable funding plan.
