Anthony Hopkin is the Director of Entomology and Phytosanitary Research at The Pacific Forestry Centre of the Natural Resources Canada's Canadian Forest Service. Anthony started as a research scientist in forest pathology at the Great Lakes Forestry Centre (GLFC) in Ontario, with the then Forest Insect and Disease Survey. He moved into the position of science Director at GLFC in 2005, and later as Director of Entomology and Phytosanitary research in Victoria BC. In his capacity as a scientist and research director, Anthony has worked closely with the CFIA and various provinces to address issues related to forest alien species.



Rebecca Lee, Ph.D, joined the Canadian Horticultural Council (CHC) in August 2016 as Executive Director. She spent six years as Technical Director of the North American Plant Protection Organization (NAPPO), where she also served as Acting Executive Director.
