International Plant Protection Commission’s (IPPC) development of a standard for international movement of grain, the Global Low Level Presence Initiative (GLI), and the recent progress of the International Grain Trade Coalition (IGTC) will also be covered. NAEGA MAP Trip Report

NAEGA President and CEO, Gary C. Martin, reported on his recent trip to Brussels, Belgium and Geneva, Switzerland in late November for IGTC stakeholder meetings. In Switzerland, Gary finalized the formal establishment of the IGTC as a non-profit organization. In both Belgium and Switzerland he met with key IGTC stakeholders. During these meetings, the recent progress of the IGTC was explained and Marcel Bruins was introduced as the new Secretariat of the IGTC. Stakeholders heard about the business plan for the future of the IGTC and were encouraged and supportive on the increased effort by the IGTC.

By working with NAEGA’s European counterpart, COCERAL, Gary was also able to secure a meeting with the Director General of Trade for the European Commission, Mr. Jean-Luc Demarty, while he was in Brussels. The common positions of the EU-US grain trade were discussed with Mr. Jean-Luc Demarty in the context of the TTIP.

U.S. Agriculture Coalition for Cuba

Several NAEGA companies and member representatives are working via NAEGA with the U.S. Agriculture Coalition for Cuba (USACC).

NAEGA members are invited and welcome to join in USACC plans for a U.S. Agri-business group visit to Cuba. Tentatively scheduled for March 1st through March 5th, 2015, the travel will likely be the first major U.S. business delegation to Cuba since U.S. President Obama announced changes to the Administration’s policy toward Cuba in December 2014. USACC has title the travel mission as a **“Learning Journey to Cuba”** and notes the Cuban government has already indicated they welcome the visit.

A public launch of the Coalition was held on January 8th, 2015 at the National Press Club in Washington, DC. The USACC is comprised of more than 30 prominent U.S. food and agriculture companies and associations who seek to advance trade relations between the U.S. and Cuba by re-establishing Cuba as a market for U.S. food and agriculture exports. Secretary Vilsack was a keynote speaker noting that Cubans import 80% of their food. The USDA reports \$415.2 million in agricultural exports to Cuba in 2013 and about \$300 million reported through the first 11 months of 2014. A number of Members of Congress and Missouri Governor, Jay Nixon, were also speakers at the Public Launch.

Information for your Consideration

Shipping Company Plead Guilty to U.S. Antitrust Violations

Nippon Yusen Kabushiki Kaisha (NYK) has agreed to enter a guilty plea and to pay a \$59.4 million criminal fine for conspiring to fix prices, allocate customers, and rig bids of international ocean shipping services. The plea agreement is subject to court approval.

“This is another step in the effort to restore competition in the ocean shipping industry to benefit U.S. consumers,” said Bill Baer, Assistant Attorney General in charge of the Department of Justice’s Antitrust Division. “Three companies have now agreed to plead guilty to participating in this long-running conspiracy. We are not done. Our investigation is ongoing.”

According to the charge, NYK and its co-conspirators conspired by agreeing on prices, allocating customers, agreeing to refrain from bidding against one another and exchanging customer pricing information. Outcomes of Recent U.S.-China Trade Talks

The U.S. Trade Representative Office (USTR) issued a [fact sheet](#) on the outcomes of the 25th U.S.-China Joint Commission on Commerce and Trade (JCCT) that took place from December 16-18 in Chicago.

In addition to China announcing import approvals for three biotech varieties of U.S. corn and soybeans and agreeing to discuss improvements in their regulatory framework for the review and approval of technology used in agriculture (see NAEGA OUTREACH Dec. 22, 2014), China also clarified its position on its Competition Law. China stated that in enforcing its Anti-Monopoly Law (AML) all business operators will be treated equally. Where AML violations are found, China is to impose enforcement measures that address the harm to competition, not measures designed to promote individual competitors or industries. China’s anti-monopoly enforcement agencies will (1) when undertaking administrative actions, strictly follow statutory limits on their authority, procedures and requirements, as laid out in China’s relevant laws, regulations and rules;

and (2) before imposing penalties, notify the parties of the facts, grounds and basis according to which the penalties are to be decided, notify the parties of their rights in accordance with the law, and provide the parties with the right to state their cases and to defend themselves.

U.S. and Mexico Outline Objectives for Improving Cross-Border Commerce

After a High-Level Economic Dialogue, U.S. and Mexico identified progress in cross-border commerce and anticipated further achievements in 2015. In a [joint statement](#), the U.S. and Mexico said, in 2014 the two sides “made significant strides regarding mechanisms for transportation and communications infrastructure planning and development” that have directly facilitated freight flows, reduced bottlenecks and improved logistics. For instance the two Governments are expediting the movement of goods and expanding supply chain security through a new mutual recognition arrangement between their trusted trader programs and the harmonization of data requirements for northbound rail shipments.

In 2015 the U.S. and Mexico will continue work to harmonize their data requirements to facilitate customs processes in all modes of transportation. Operations of three new facilities will be initiated: the West Rail Bypass in Matamoros, Tamaulipas-Brownsville, Texas; the Guadalupe-Tornillo port of entry in Chihuahua-Texas; and the Tijuana Airport Pedestrian Facility. Progress is anticipated on the proposed Otay II border crossing in the Tijuana-San Diego border region. Regulatory cooperation will be pursued in such areas as energy, food safety and transportation to facilitate cross-border trade and co-production.
