IGC Meeting and Forum

On December 1, the International Grains Council and the Buenos Aires Bolsa de Cereales will hold a forum titled *The New Global Context: Challenges and Opportunities of Large Net Exporters* in Buenos Aires, Argentina. NAEGA Support for Cuba Ag Exports Act

Last week, NAEGA (via the U.S. Agriculture Coalition for Cuba) offered its support to the Cuba Agriculture Exports Act. The act removes key barriers to agricultural trade with Cuba by modifying the prohibition of certain U.S. assistance and financing for agricultural exports to Cuba currently in place under the Trade Sanctions Reform and Export Enhancement Act of 2000. Specifically, the act would:

- Repeal the TSRA financing restrictions, same as the Heitkamp/Boozman bill
- Exempt MAP, FMD, GSM-102, and Federal Checkoff programs from TSRA restrictions on government assistance in Cuba
- Enables limited investment in Cuban agribusinesses subject to the following constraints:
 - Must be an agribusiness
 - Must be a private entity not affiliated with the Government of Cuba or its agents
 - Cannot be located on confiscated land of Cuban nationals

These changes address some of the longstanding U.S. barriers to agriculture trade with Cuba, particularly regarding trade financing.

U.S. Review of Coordinated Biotechnology Framework – NAEGA will be engaged in a White House initiative intended to update and improve the U.S. Coordinated Biotechnology Framework. The White House issued a memorandum directing the three federal agencies with oversight responsibilities for the products of biotechnology—the Environmental Protection Agency (EPA), the Food and Drug Administration (FDA), and the Department of Agriculture (USDA)—to update the Coordinated Framework, develop a long-term strategy to ensure that the system is prepared for the future products of biotechnology, and commission an expert analysis of the future landscape of biotechnology products to support this effort.

comment period regarding its proposed plan to strengthen oversight of genetically engineered wheat field trials. The proposed plan would require future field trials to be conducted under APHIS permit. This permitting process is proposed after two recent detections of GE wheat in unauthorized areas. APHIS will consider all public comments received on or before October 26, 2015.

ITC Review of Economic Impact of Trade Agreements – Prompted by a request from Congress, the U.S. International Trade Commission (USITC) has begun an investigation into the economic impacts of U.S. trade agreements since 1984. This investigation will include bilateral and multilateral agreements, including the Uruguay Round of negotiations, and will take place over a period of 8 months. Submissions of public statements will be accepted until November 4. A public hearing on the report will be conducted on November 17, and the report will be submitted to Congress on June 29.

Export-Import Bank Back?

The Export-Import Bank, whose charter expired on July 1, could soon be back in business if a new legislative effort moves forward in Congress. Currently, a bipartisan group of lawmakers are pushing for a vote on the bank after the filing of a discharge petition, the first since 2002. Led by Rep. Frank Lucas (R-OK), the discharge petition, which is a means of bypassing a committee and bringing a bill to the floor if a majority of the body are signatories, could circumvent House leadership and force a vote on the bank. If brought to the floor, the bank's charter could be approved by the bipartisan coalition of Democrats and Republicans who supported the petition. A re-charter of the bank was already authorized in the Senate as part of the Highway Trust Fund reauthorization, but another vote would be required.

Under its previous charter, the Export-Import Bank offered credit guarantees, risk insurance, and other financial services to exporters. Some Republicans, who argue that it is corporate welfare, effectively killed its re-charter earlier this summer.

USDA Released Information on Negotiated TPP

The U.S. Department of Agriculture has released a report on the agriculture provisions of the recently concluded TPP agreement. While the final text of the agreement will not be available for some time, USDA's report gives some insights into the market access gains provided by the agreement. In particular, U.S. corn producers will see increased market access gains for corn in the form of reduced tariffs for non-feed products and increased country specific quotas (CSQ) for certain starches. In addition, Japan, Malaysia, and Vietnam will eliminate tariffs on soybean oil, and Japan will increase its CSQ for wheat and lower tariffs on processed wheat products.
