1. Established a 2014 special assessment for \$150,000 of all 12 full members reporting more than 100 million bushels of exports shared equally to cover NAEGA 2014 operating deficit.
2. Established a special committee of the Board of Directors designated to consider and report on options for membership categories and membership funding of the association. The Chairman of the Board will name the committee and the committee will report by May 31. The NAEGA staff will assist the committee.
3. Decided that NAEGA staff will provide recommendations for changes to the NAEGA bylaws and business operations with a focus on, and including, revised mission, purpose, and operating structure. The staff will provide a report on the recommendations to the Board by May 15.
4. Directed the Board of Directors, to the extent provided to it by the current bylaws, to make changes to membership financing, mission, purpose, and operating structure by October 1. And propose revisions to the bylaws by October 1.
5. Decided to renew NAEGA’s USDA Market Access Program (MAP) application for 2015.
6. Approved the NAEGA contact directory as recommended. A copy of the directory on the NAEGA Members’ site can be found [here](#). For immediate access to the directory, click [here](#). Please review the contact directory, and let us know if you have any changes.
7. Reapproved \$2,000 to reimburse costs to Steve Lucas, Maria Reinitz, and Amer Badawi to pursue acceptance as AAA arbitrators.

NAEGA and NGFA Grades and Weight Committee members were addressed by Bob Lijewski from USDA-FGIS. Mr. Lijewski covered a number of topics including export volumes, labor issues in the Pacific Northwest, discrepancies in moisture readings (for more detail, see the moisture meter article below), and OSHA citations and other regulatory updates. Randall Jones, Deputy Administrator of FGIS, was scheduled to be present at the meeting, but cancelled his trip due to flight issues.

NAEGA members and NGFA’s biotechnology committee industry representatives also held a series of Biotechnology Committee meetings. Topics at these meetings covered the International Grains Trade Coalition (IGTC), NAEGA’s coexistence comments and aggressive commercialization, Low Level Presence (LLP) initiatives, the U.S. Biotech Crops Alliance, pre-emptive labeling of GMOs, and China’s possible approval of MIR 162.

IPPC Commission on Phytosanitary Measures Meeting

Kirk Miller secured observer status at the International Plant Protection Convention’s (IPPC) [Commission on Phytosanitary Measures](#) (CPM) meeting during the week of March 31 in Rome, Italy. Kirk learned the idea of traceability is not dead and the IPPC is interested in working with the International Grain Trade Coalition (IGTC) on the drafting group for the International Standards for Phytosanitary Measures (ISPM). NAEGA hosted USDA and Mexico’s SENASICA officials at a reception on March 27th in Kansas City. The reception was followed by a discussion at the FGIS Technical Center on the morning of Friday, March 28th. These events provided for an important opportunity to consider and respond to details of Mexico’s “soil pod” issue. The topics of discussion were focused on trade facilitation and Mexico’s phytosanitary risk management procedures, including ongoing trade concerns with SENASICA’s implementation of measures to address “soil contamination.”

At the reception on Thursday, March 27th, Alan Barkema, former Senior Vice President of the Kansas City Federal Reserve Bank gave a presentation entitled, “Agriculture, Trade and NAFTA Economic Overview.”

A copy of an English version of SENASICA’s border manual for inspection and certification and draft procedures for grain found contaminated with soil can be found [here](#). The soil procedures document is of particular concern since it provides for Mexican monitoring of U.S. inspection, makes the requirements for fumigation more rigorous, and includes a traceability documentation requirement.

U.S. Moisture Meter Concerns

Several NAEGA member companies have recently reported concerns with discrepancies in USDA official determination of moisture. NAEGA and NGFA are working with USDA GIPSA FGIS officials to investigate and mitigate the circumstances.

In a related action USDA has notified that the accuracy of the sensor in DICKEY-john GAC 2500UGMA moisture meter can be compromised if the operator fails to perform the recommended routine maintenance to keep the infrared sensor very clean. Any dust on the sensor lens or other surfaces within the sensor can interfere with the infrared temperature sensor’s response to the temperature of the grain sample. The potential effects of such interference increase significantly for extreme sample temperatures. Such interference tends to cause the measured sample temperature to be closer to room (instrument) temperature than it should be. Sample temperature measurement errors contribute moisture measurement errors of approximately 0.1 % moisture per degree Celsius of temperature measurement error (or about 0.1 % moisture per two degrees Fahrenheit). DICKEY-john [has provided a reminder](#) to official service providers and all of its customers to be attentive to the need to keep the temperature sensor clean (along with a copy of the cleaning procedure that is in the GAC 2500 User’s Guide). In addition to the DICKEY-john reminder, FGIS has strongly recommended official inspection laboratories conduct an additional check procedure is to verify that sensor cleanliness is adequate to provide accurate temperature compensation.

A WTO committee failed to agree on a definition for private standards for food safety and animal and plant health, and deferred a decision on a mediation procedure designed to avoid legal disputes, when it met on 25–26 March 2014. These issues have been discussed for several years in the Sanitary and Phytosanitary Measures (SPS) Committee. The committee, which consists of all 159 WTO member governments, monitors how countries are applying the [WTO SPS Agreement](#), which deals with food safety and animal and plant health, and discusses issues arising from these rules and from individual countries’ measures.

With no consensus on a definition for private SPS standard, the committee accepted a suggestion from Canada to look at definitions for private standards used in other international forums and to try to adapt these to SPS. However, the failure to agree on a definition aroused concern from some members and a decision on the [proposed compromise on the mediation procedure](#) has been delayed until the next meeting, starting July 7, 2014.
