Reports on NAEGA Actions

Asia and Americas – Trans-Pacific Partnership (TPP)

NAEGA continues to support effective measures to deal with Sanitary and Phytosanitary (SPS) and Technical Barriers to Trade (TBT). In a paper on SPS and TPT issues, NAEGA argues that the best opportunity to provide for greater and more consistent international trade in agricultural products throughout the TPP region is to establish SPS and TBT measures that are enforceable and trade facilitative. Towards that end, TPP countries have devoted considerable work to developing new SPS commitments in TPP that build upon existing World Trade Organization disciplines in order to strengthen and reinforce existing rules, as well as to underscore the importance of science-based regulation.

In order for a TPP agreement to be effective it must include new disciplines on the application of Sanitary and Phytosanitary (SPS) measures that effectively respond to emerging trade challenges. As TPP negotiators work towards concluding negotiations, ensuring such SPS measures are truly effective through the use of enforceability mechanisms is a critical issue to address the needs of food and agricultural sectors in each of the TPP countries. The following principles are critical to a successful TPP negotiation:

1. Enforceability is Key
2. Scientific Basis
3. Rapid Response Trade Facilitation
4. “WTO-plus” SPS Provision

TPP SPS commitments, including “WTO-plus” elements, must be enforceable. The addition of a TPP Rapid Response Mechanism, applied to SPS and TBT measures, is needed to facilitate trade and help provide a speedy method for resolution of shipment-specific issues.

Canada and U.S. – PNWER Summit

The Pacific Northwest Economic Region Summit will be held this week in Anchorage, Alaska. NAEGA’s president, Gary Marten, will attend meetings of an Agricultural Working Group at the conference. Mr. Martin’s advocacy effort will seek for action from the PNWER to:

1. Endorse and coordinate with the work and action plans of the Regulatory Cooperation Council (RCC) and the Canada–United States Consultative Committee on Agriculture (CCA). Key elements of this work should include:
 - Harmonization of regulatory labeling differences. For example, different standards related to nutritional information and the use of terms such as “natural.”
 - Potential harmonization of ingredients regulations.
 - Trade Facilitation via improvements in implementation of regulations including deployment of a Rapid Response Mechanism.
2. Address U.S. Country of Origin Labeling (COOL) recognizing that U.S.’s mandatory COOL has been found by the World Trade Organization (WTO) to discriminate against imported livestock creating challenges for Canadian cattle and hog producers. The USDA rule violates the United States Constitution by compelling speech in the form of costly and detailed labels on meat products that do not directly advance a government interest. In addition, the new 2013 regulation that will be implemented in a few months exceeds the scope of the statutory mandate, because the statute does not permit the kind of detailed and onerous labeling requirements the final rule puts in place, and that the rule is arbitrary and capricious, because it imposes vast burdens on the industry with little to no countervailing benefit.
3. Support efforts related to accommodating a Low Level Presence (LLP) of GM in imported agricultural products currently threatening importing and exporting countries alike and global food security in general.

For the purpose of this initiative, NAEGA is encouraging that the following definitions apply:

- Low-Level Presence (LLP): “low levels of recombinant DNA plant materials that have passed a food safety assessment according to the Codex Guideline for the Conduct of Food Safety Assessment of Foods Derived from Recombinant-DNA Plants (CAC/GL 45-2003) in one or more countries, but may on occasion be present in food in importing countries in which the food safety of the relevant recombinant-DNA plants has not been determined.”

- LLP from asynchronous approval: “may occur when the country of export has already approved a GM event for cultivation, while the country of import is in the process of authorizing it”
 - LLP from isolated foreign approval (often described as asymmetric approval): “may occur when the country of export approves a GM event for commercial production and in the country of import no submission for the approval is sought by the developer of the event or in which an approval is not to be granted for reasons falling outside food safety”.
 - LLP from discontinued event: “may occur when the approval of the GM event expires and the technology developer does not submit an application for the continuation of the approval.”
 - Adventitious Presence (AP) of research events (often described as “field escape”): “AP refers to the unintentional presence of GMOs that have never been authorized in any country on the basis of the Codex international guidelines for food plant safety assessment”.
4. Support negotiations for a Trans Pacific Partnership (TPP) trade agreement that encourages all governments to work toward an ambitious agreement that liberalizes agriculture trade by resolving the negotiations should include:
- An LLP Policy (see point 3 above)
 - All elements of trade and investment, including agriculture, goods, services, digital trade, competition policy, and intellectual property.
 - No product or sector exclusion from the negotiations
 - Phase out of all tariffs and other market access barriers by the end of a negotiated transition period.
 - Establishment of risk based scientific decision making, regulatory convergence, and equivalence that includes robust science based the Sanitary and Phytosanitary measures to facilitate trade.
 - Obligations that go beyond those in the WTO and are subject to TPP enforcement provisions, including in the Sanitary and Phytosanitary chapter.
 - A “Rapid Response Mechanism” (RRM) to facilitate trade when administrative entities implement Sanitary and Phytosanitary (SPS) measures and other regulations, standards, testing and certification procedures that may result in Technical Barriers to Trade (TBT).
 - An agreement that is a single undertaking. All elements of the negotiation, including both tariff and nontariff SPS measures, are part of an indivisible package and cannot be agreed separately. In other words, nothing is finalized until everything is finalized.
5. Building a stronger relationship between The PONWER and he Canada-U.S. Grain and Seed Trade Task Group that includes facilitating PNWER industry input into the ongoing activities and agenda of the Task Group. .

U.S. – CFTC Agricultural Advisory Committee

NAEGA has recently accepted an invitation from the Commodity Futures Trading Commission (CFTC) to nominate a representative to serve on the Agricultural Advisory Committee (AAC). NAEGA nominated Steve Strong of Bunge, USA to be the representative of NAEGA on the AAC. Mr. Strong will serve on the AAC for a term of Two years and will be charged with presenting the views and interests of NAEGA and its members to the AAC and CFTC.

Mr. Strong is quality choice to serve as NAEGA’s representative on the AAC because of his professional experience and his ability to directly and indirectly act on behalf of NAEGA. Mr. Strong’s nomination is now contingent on CFTC confirmation.

U.S. –USAEDC’s Attaché Conference

NAEGA staff attended the U.S. Agricultural Export Development Council’s (USADC) Attaché conference in Alexandria, VA on July 9th and 10th. The conference allowed for NAEGA staff to talk with attaché’s deployed around the world about relevant trade issues. NAEGA talked with representatives from China, South Korea, Brazil, and Kenya. NAEGA also talked with USDA specialists about its Market Access Program (MAP) funding.

The conference was also an opportunity for NAEGA to hear from agricultural industry leaders discuss international trade issues and opportunities. Although TPP and TTIP trade negotiations were general themes of conversation, the conscious was that there will be real opportunity for agricultural trade in Africa in the coming years.

The conference was highlighted by the Keynote address given by Secretary of Agriculture, Tom Vilsack. The Secretary addressed the importance of international trade and the role it has played to advance the agricultural economy. He also passionately spoke of how important it is for Congress to pass a five-year farm bill.

New Issues & Opportunities for NAEGA Consideration

EU – List of GMOs Authorized for Market the EU

In accordance with Regulation (EC) No 1829/2003, the EU has released an updated list of GMOs which are authorized for placing on the market in the EU. The full list of authorized GMOs in the EU and related safety information is available at the [EuropaBio website](#).

U.S. – Court Ruling Against Union for Grain Exporter

In *Ahearn v. Int’l Longshore and Warehouse Union*, the Ninth Circuit of Appeals ruled that the Longshore and Warehouse Union (Union) was in contempt of a preliminary injunction placed on it by the District Court. The Union began picketing at Export Grain Terminal, LLC (EGT) on June 11, 2011 in hopes of EGT ceasing business with its employer, the Port of Longview. On the morning of September 8, 2011 picketers approached the EGT facility with “gardening spears, baseball bats, broom sticks, and metal pipes.” The picketers caused a great amount of damage to the facility ranging from breaking windows to cutting air hoses. Later that day the district court issued a preliminary injunction enjoining the Union’s conduct. On September 21, 2011 the Union blocked the railroad tracks leading to the EGT facility, which prevented a BNSF train from making a delivery. The district court held the Union in contempt of the preliminary injunction and awarded EGT compensatory damages.

The Ninth Circuit Court of Appeals upheld the district court’s decision, holding that EGT was entitled to compensatory damages. The Court declared that the purpose of a civil contempt order was to compensate the prevailing party and coerce compliance with the court order. Here, EGT deserved to be compensated, not only for the damage done, but also deserved to have the injunction enforced. Finally, the Court decided that the district court did not abuse its discretion in the amount of damages it awarded.
