IGTC Africa Grains Weeks – May 6-17, 2023

NAEGA member and associate member personnel are welcome to attend <u>Africa Grains Weeks Programs</u> from May 6-17 in Kenya (Nairobi) and South Africa (Pretoria, Johannesburg, and Bothaville). The International Grain Trade Coalition (IGTC) is coordinating business events and educational tours in both countries, with assistance of the Eastern Africa Grains Council (EAGC) and the South Africa Cereals and Oilseeds Trade Association (SACOTA).

The Library is constantly being updated with reports on initiatives related to food systems, trade, and global food security as well as outcomes from the UNFSS. Recent entries include an International Grain Trade Coalition (IGTC paper submitted to 17th Commission on Phytosanitary Measures and a study from the FAO regarding global employment in agrifood systems.

Current and Ongoing Actions

U.S. Soybean Standards

United States Standards for Soybeans are under consideration. USDA's Agricultural Marketing Service (AMS) Proposed Rule in the U.S. Federal Register eliminates SBOC as a grading factor and retains SBOC as part of the Yellow soybeans class. AMS also proposes to revise the regulation related to "inspection of shiplot, unit train, and lash barge grain in single lots" by removing SBOC from the Grade Limits and Breakpoints for Soybeans table. If approved, the new standards would go into effect on September 1, 2023.

The Grades & Inspections committee is considering a response and your comments and input are welcome. The deadline for comments to USDA/AMS is May 1, 2023.

Rome, Italy – March 27-31, 2023

NAEGA Geneva Envoy Mariya-Khrystyna Koziy travelled to Rome, Italy as a part of the International Grain Trade Coalition (IGTC) delegation to the 17th Session of the Commission on Phytosanitary Measures of the International Plant Protection Convention (CPM-17). The weeklong agenda was led by the IPPC's 184 governmental Contracting Parties, chaired by Cote d'Ivoire and vice-chaired by the U.S. The overarching objective focused on furthering the IPPC's objectives to protect the world's plant resources from the spread and introduction of pests and promote safe trade. The IGTC delegations also met with representatives from the U.N Food and

Agriculture Organization and the World Food Program. A trip report will be available on the NAEGA Member's Only website soon.

News:

European Market Policy Assessment

The U.S. Sustainability Alliance (USSA), of which NAEGA is a member, <u>has published a European Market Policy Assessment for the first quarter of 2023</u>. The report summarizes key developments in the European agricultural sector and their impact on USSA goals, with a focus on the impact of the Russian invasion of Ukraine on the EU's agricultural trade position, analysis of the EU's Green Deal initiatives, and the implementation progress of the EU's Common Agricultural Policy, among other topics.

Geneva Update – March 2023

World Trade Organization (WTO) events of interest are detailed in <u>this March 2023 Geneva update</u> from our Geneva Envoy Mariya-Khrystyna-Koziy:

- On March 9th, in advance of the extension of the Black Sea Grain Initiative, the UN Conference on Trade and Development published a report on the impact of the initiative, highlighting its contribution to global food security.
- WTO members discussed how to enhance the organizations' work amid the rising use of trade measures for environmental objectives.
- Discussions at the regular meeting of the Committee on Agriculture (March 27-28) testified to the need to strengthen efforts to ensure global food security. At the meeting, Members heard updates on food markets and the current outlook for global food security.
- WTO's Director General Ms. Okonjo-Iweala announced her decision to create the Transformation Office that would work on developing a vision and an overarching strategy/mission statement for the Secretariat.

Information Services:

Plant Biotechnology Information Exchange (PBIE)

There are currently 2,778 transgenic products from approximately 415 unique transgenic events and 502 gene edited products in the <u>NAEGA PBIE</u>.

Developed by and at the request of membership, the PBIE contains detailed information on commercialized and pre-commercialized gene-edited and transgenic seeds used to produce the crops you use and market. Currently, only NAEGA members have access to this unique tool. As part of membership, your company is allowed up to five unique users for the PBIE at no cost.
