

#### USDA/FAS ESRMS 2.1 User Acceptance Testing - Ends May 31, 2023

The USDA/FAS Export Sales Reporting and Maintenance System (ESRMS2.1) is open for User Acceptance Testing. FAS is requesting that all exporters enter the ESRMS 2.1 Test System to

perform user acceptance testing to become familiar with the system and to test the bulk electronic upload process. USDA also requests feedback from all exporters to ensure the functionality and compatibility of the final system design. ESRMS 2.1 and the ESRMS 2.1 Query System are for testing only and are not to be used for any other purpose. All data entered in the test site will be removed before the launch of ESRMS 2.1. Testing is open through the end of May 2023.

## **Current and Ongoing Actions**

### **United Kingdom SPS Measures**

The United Kingdom has <u>notified the World Trade Organization (WTO)</u> that it plans to update and streamline border control measures and mechanisms. In addition to the U.K. Single Trade Window, <u>the proposed Border Target Operating Model</u> would implement new Sanitary and Phytosanitary controls at the UK's borders. If implemented the following changes would become effective from January 31, 2024:

- A global risk-based approach: live animals, germinal products, products of animal origin, animal by-products, plants, and plant products will be categorized as high, medium, or low risk, with controls appropriately weighted against the risks posed both by the commodity and the country of origin.
- **Digitized phytosanitary certificates:** PC's will be digitized in line with UK trade partners' readiness.
- **Use trust**: Authorized importers of plants, plant products, and some animal products may be eligible for streamlined controls if they provide enhanced assurances and evidence that they are meeting regulatory requirements.

NAEGA is considering a response and your input and advice are welcome. Comments are due to the WTO on May 12, 2023.

#### **Vietnam Canada Thistle**

The Government of Vietnam has notified the World Trade Organization (WTO) Committee on Sanitary and Phytosanitary Measures of <u>a list of plants the Government plans to add to its regulated pest list</u>, including designating Canada/Creeping Thistle (*C. arvense*) seed as a quarantine pest. <u>A 2019 USDA review of Vietnam's pest risk analysis for Canada/Creeping Thistle</u> found that there is "no evidence that *C. arvense* is a weed in tropical area and it does not have invasive potential in Viet Nam"

The Grades & Inspections Committee is considering a response and your input is welcome. Comments are due to the WTO on May 21, 2023.

### **Geneva Update**

World Trade Organization (WTO) events of interest <u>included in this update</u> from Geneva Envoy Mariya-Khrystyna Koziy:

- From April 25 to May 4 the WTO Director-General, Ngozi Okonjo-Iweala, is visiting Ghana, Côte d'Ivoire, and Kenya to meet with leaders, policymakers, private sector, and civil society representatives to strengthen the WTO's support for Sub-Saharan Africa.
- On April 27, WTO's Deputy Director-General Angela Ellard <u>spoke</u> at an event organized by the Inter-Parliamentary Union in the European Parliament in Brussels and encouraged parliamentarians from around the globe to deepen their support for the WTO.

- On May 2, H.E. Dr. Mokgweetsi E.K. Masisi, the President of Botswana, delivered the <u>WTO Presidential Lecture</u>, discussing Africa's expectations from the multilateral trading system.
- At the WTO's Committee on Subsidies and Countervailing Measures meeting, China challenged the US over WTO rules on CHIPS and Inflation Reduction Acts, claiming that the US is using climate concerns as a cover for protectionism.

### **Recent Actions**

#### **Treated Seed Prevention**

In support of an industry-wide effort to communicate the need to not allow treated seeds in the grain and oilseed commodity supply, NAEGA sent a letter to industry partners promoting communication with the public and constituent organizations throughout the year.

Resources on treated seed management include:

- The American Seed Trade Association and Crop-Life America's "Guide to Seed Treatment Stewardship", an industry-wide initiative to promote the safe handling and management of treated seed. The purpose of the Guide is to provide farmers and seed companies with critical information and up-to-date guidelines for managing treated seed effectively to further minimize the risk of exposure to non-target organisms. We encourage you to visit the <a href="Guide website">Guide website</a>.
- The National Grain and Feed Association (NGFA) has "Treated Seed Guidance" which outlines best practices for handling treated seeds and proper disposal of treated seeds. The best practices for preventing treated seeds from being mixed with grain are to handle treated seeds with separate and dedicated equipment. Disposal of treated seeds should be done in compliance with state and local regulations. - The U.S. soybean family notes that "because U.S. farmer compliance is critical to avoid disruption of U.S. soybean exports to overseas markets, disposal recommendations were included in the 'Treated Seed Disposal' section of the Pesticide Environmental Stewardship website of the Center for Integrated Pest Management". #### **U.S. Soybean Standards**

NAEGA joined a broad coalition of industry partners in supporting a proposed rule from USDA's Agricultural Marketing Service's (AMS) which would change U.S. Standards for Soybeans by removing soybeans of other color (SBOC) as a grade-determining factor but retain it in the standards as part of the definition of the class Yellow Soybeans. If approved, the new standard would take effect on September 1, 2023

## **Global Trade Growth Slowing**

The World Trade Organization (WTO) released updated projections for global trade in 2023. The projections, set out in the <u>April 2023 "Global Trade Outlook and Statistics" report</u>, estimate trade

volume to grow by just 1.7% in 2023, down from 2.7% growth in 2022. The report cites the war in Ukraine, high inflation, tighter monetary policy, and financial market uncertainty as key factors.

## **U.S.-Kenya Trade**

The United States and Kenya concluded the second round of negotiations under the U.S.-Kenya Strategic Trade and Investment Partnership (STIP). Announced in July 2022 as an alternative to a bilateral trade agreement, STIP goals include increased investment; promotion of sustainable and inclusive economic growth; and supporting African regional economic integration, including agricultural trade. U.S. Trade Representative Katherine Tai expressed hope that the STIP "can serve as a model for trade policy engagement in Africa," and Kenyan trade minister Moses Kuria praised the "tremendous advancements" made in the latest round of talks. Several dialogues between the two countries are planned for the rest of 2023.

### **U.S. OFAC Compliance**

The U.S. Treasury's Office of Foreign Asset Control (OFAC) issued the statutory maximum civil monetary penalty applicable to a U.K.-based firm in a recent case where the company settled charges arising out of a scheme to do business in North Korea through a third-party company in Singapore. OFAC is using this case, where the penalty was over \$600 million, to stress the importance of full compliance with sanctions and that "creating the illusion of distance between a firm and apparently violative conduct does not shield that firm from liability." OFAC recommends companies reevaluate their sanctions risk exposure as new sanctions are handed down. U.S. sanctions information from the OFAC can be found through this link. ### Plant Biotechnology Information Exchange (PBIE)

There are currently 2,7781 transgenic products from approximately 415 unique transgenic events and 503 gene-edited products in the <u>NAEGA PBIE</u>.

Developed by and at the request of membership, the PBIE contains detailed information on commercialized and pre-commercialized gene-edited and transgenic seeds used to produce the crops you use and market. Currently, only NAEGA members have access to this unique tool. As part of membership, your company is allowed up to five unique users for the PBIE at no cost.
