ESRMS 2.1 User Acceptance Training

The U.S. Department of Agriculture (USDA) Foreign Agriculture Service (FAS) is encouraging exporters to complete User Acceptance Training (UAT) for the Export Sale Reporting and Maintenance System (ESRMS) 2.1 platform as soon as possible.

FAS is requesting that all exporters enter the ESRMS 2.1 Test System to perform user acceptance testing to become familiar with the system and to test the bulk electronic upload process. USDA also requests feedback from all exporters to ensure the functionality and compatibility of the final system design. ESRMS 2.1 and the ESRMS 2.1 Query System are for testing only and is not to be used for any other purpose. All data entered in the test site will be removed before the launch of ESRMS 2.1. The Test System will remain open for UAT until all exporters have completed the training.

Current and Ongoing Actions

Export Sales Reporting and Maintenance System 2.1

NAEGA members and staff met with U.S. Department of Agriculture (USDA) staff working on the <u>update to the Export Sales Reporting and Maintenance System (ESRMS)</u> on June 29, 2023 to provided direct feedback to USDA on the revisions made to the reporting System, frequency and burden of reporting as part of the development of the ESRMS 2.1 platform, and other concerns as they relate to changes in reporting that are part of the update to the system. USDA continues to use the legacy ESRMS system for reporting and has not set a date for the launch of ESRMS 2.1.

NAEGA plans to submit written comments to USDA, and your input is welcome. Comments are due on July 14.

Recent Actions

APPAMEX-NAEGA Forum

The 28th APPAMEX-NAEGA Forum took place June 15-17, 2023 in Cancun, Mexico NAEGA was represented in person by Oscar Omar Mendoza of Cargill, and virtually via <u>a keynote address</u> by Sofia Flores Palomar on the "Declaration on Sanitary and Phytosanitary Measures of the 12th Ministerial Conference of the World Trade Organization" and a presentation on the Global Trade & Food Security Library by Senior Advisor Katy Lee. The Forum also featured discussions on the future of North American Agricultural Trade and Mexico's approach to biotechnology. Special thanks to Oscar Omar Mendoza and Cargill for representing NAEGA.

IGTC Geneva Dialogue

NAEGA staff completed 2 months of support for International Grain Trade Coalition (IGTC) programming, including previously reported events in Kenya, South Africa, Switzerland and the United Kingdom, by organizing and participating in IGTC's Geneva Dialogues on June 19 & 20 in Geneva, Switzerland.

Events included a Global Food Security and Grains Seminar at the World Trade Organization (WTO), focused on cooperation between the public and private sectors for the benefit of global food security and trade and featured a series of in-person meetings and events with speakers, decision-makers, and thought leaders from around the world.

Attendees included Geneva-based governmental representatives to the, such as Australia, Argentina, Brazil, New Zealand, Paraguay, UK, USA, Uruguay, Vietnam, and several IGTC Member and Stakeholder representatives. Follow-up discussions centered on issues such as agriculture trade negotiations, the importance of trade for Global Food Security, and opportunities for private sector engagement at the WTO, among others.

Staff also took part in an Dialogue and Luncheon on Innovation and Sustainability opportunities for the Grain Trade hosted by Corteva. A trip report will be available soon.

USDA/APHIS Letter to Japan on Fumigation

USDA's Animal & Plant Health Inspection Service <u>sent a letter to Japan's Ministry of Agriculture</u> <u>Forestry and Fisheries (MAFF)</u> is response to MAFF's request for information regarding phytosanitary treatments for U.S. grains shipments. The letter, supported by input from the NAEGA Grades & Inspections Committee, details the use of phosphine gas for fumigation and other potential treatments, as well as the safe handling and disposal of tubing used for in-transit fumigation on bulk vessels.

News:

Geneva Update

World Trade Organization (WTO) events of interest <u>included in this update</u> from Geneva Envoy Mariya-Khrystyna Koziy:

- In June the WTO organized the 4th Trade and Environment Week, focused on collective approaches to address climate change, natural disasters, pollution, and biodiversity loss in the context of global trade.
- The WTO Secretariat circulated a draft report to the 13th Ministerial Conference, presenting seven findings based on the discussions held in line with the SPS Declaration adopted at MC12 on key challenges and opportunities in implementing the SPS Agreement.
- WTO's Director-General Ngozi Okonjo-Iweala announced the creation of two advisory groups to exchange views and engage in discussions with the WTO's key stakeholders. One consists of business leaders, while the other comprises prominent civil society representatives.
- On June 21–22, new submissions were discussed in the Committee on Agriculture in Special Session to revitalize agriculture negotiations ahead of the next Ministerial Conference set for February 2024.

EU Draft Legislation on Gene Edited Crops

The European Commission released <u>draft legislation on "plants obtained by certain new genomic</u> <u>techniques and their food and feed"</u> that the Commission said is designed to make the EU's agricultural systems more "sustainable and resilient". The legislation would separate gene edited products into two categories: those "comparable to naturally occurring or conventional plants" and those with "more complex modifications". Under the proposed regulation, food and feed products

which fell into the first category would be treated as conventional products and not subject to the EU's existing GMO regulations. Products under the second category would be subject to those regulations. There will be a process required to verify that a product is "comparable to naturally occurring or conventional plants". The legislation will next move to the European Parliament for consideration.

Information Services:

Plant Biotechnology Information Exchange (PBIE)

There are currently 2,835 transgenic products from approximately 420 unique transgenic events and 506 gene-edited products in the <u>NAEGA PBIE</u>.

Developed by and at the request of membership, the PBIE contains detailed information on commercialized and pre-commercialized gene-edited and transgenic seeds used to produce the crops you use and market. Currently, only NAEGA members have access to this unique tool. As part of membership, your company is allowed up to five unique users for the PBIE at no cost.
